*"-": the wind velocity is below 0.5m/s

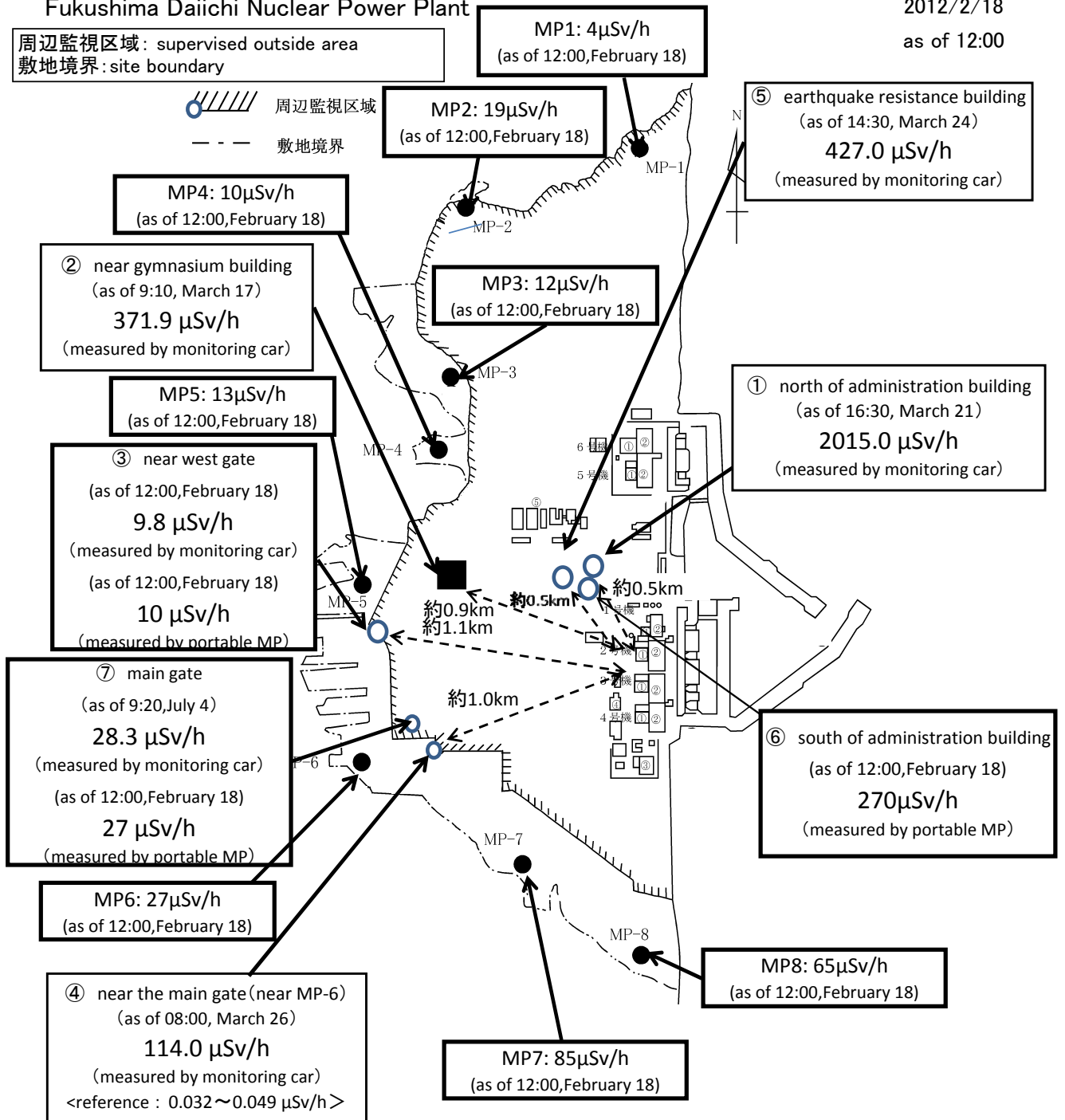
