- \*1 : Instrument failure
- 32 Continuously monitoring the status (Meters which showed some fluctuation in the records but were not concluded as malfunction and of which the transition of the records are under observation.)
- 3 : In case that the instrument indicates minus hydrogen density, "0%" is recorded. (Because there's the possibility of minus indication due to the instrumental precision when hydrogen density is very low.)
- \*4: In case that the instrument reading is below measurable limit, "ND" is recorded.
- 35 : Flow rate values are adjusted according to the temperature and the pressure under usage conditions.
