[Information about measurements] *1 : In case that the instrument indicates minus hydrogen density, "0%" is recorded (Because there's the possibility of minus indication due to the instrumental precision when hydrogen density is very low.) The hydrogen concentration in the PCV gas control system is provided.

*2 : In case that the instrument reading is below measurable limit, "ND" is recorded. The radioactivity density (Xe135) in the PCV gas control system is provided.

*3 : Flow rate values are adjusted according to the temperature and the pressure under usage conditions.

*4 : Nitrogen gas injection is under suspension.
