^{35 :} Due to the planned outage at circulating water cooling system for spent fuel pool of Unit 1, recent data are shown for both temperature of spent fuel pool at Unit 1 and water level of FPC skimmer surge tank. The estimated water temperature of spent fuel pool at the end of the planned outage scheduled on 17:00 March 12 is approximately 23.5 °C.
