Detection limits at the West Gate of Fukushima Daiichi are as follows:

Volatile: I-131: approx. 1E-7Bq/cm<sup>3</sup>, Cs-134: approx. 3E-7Bq/cm<sup>3</sup>, Cs-137: approx. 4E-7Bq/cm<sup>3</sup>      Particulate: I-131: approx. 7E-8Bq/cm<sup>3</sup>, Cs-134: approx. 2E-7Bq/cm<sup>3</sup>

Detection limits at MP-1 of Fukushima Daini are as follows:

Volatile: I-131: approx. 2E-6Bq/cm<sup>3</sup>, Cs-134: approx. 3E-6Bq/cm<sup>3</sup>, Cs-137: approx. 3E-6Bq/cm<sup>3</sup>      Particulate: I-131: approx. 9E-7Bq/cm<sup>3</sup>, Cs-134: approx. 1E-6Bq/cm<sup>3</sup>, Cs-137: approx. 2E-6Bq/cm<sup>3</sup>

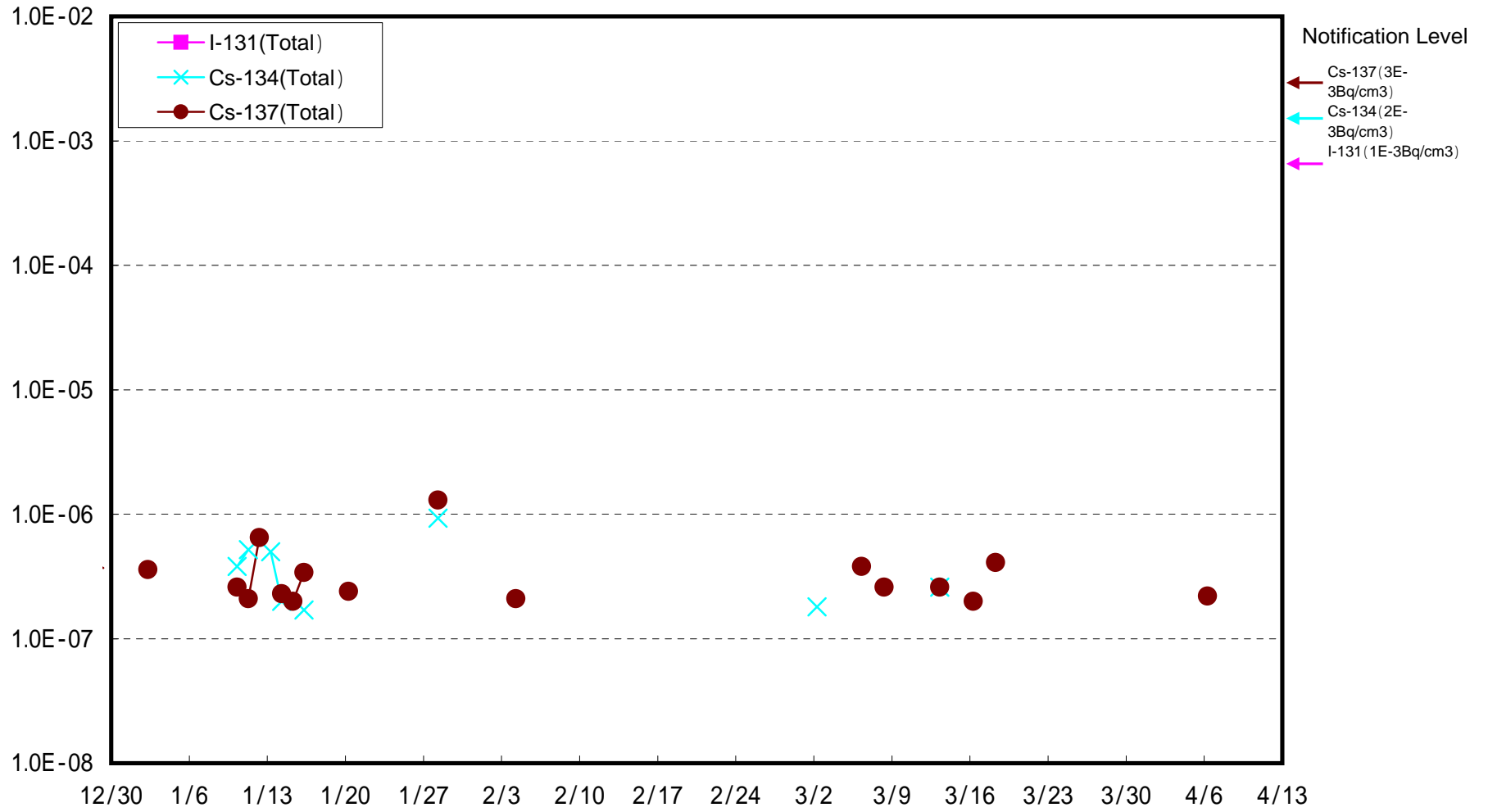
