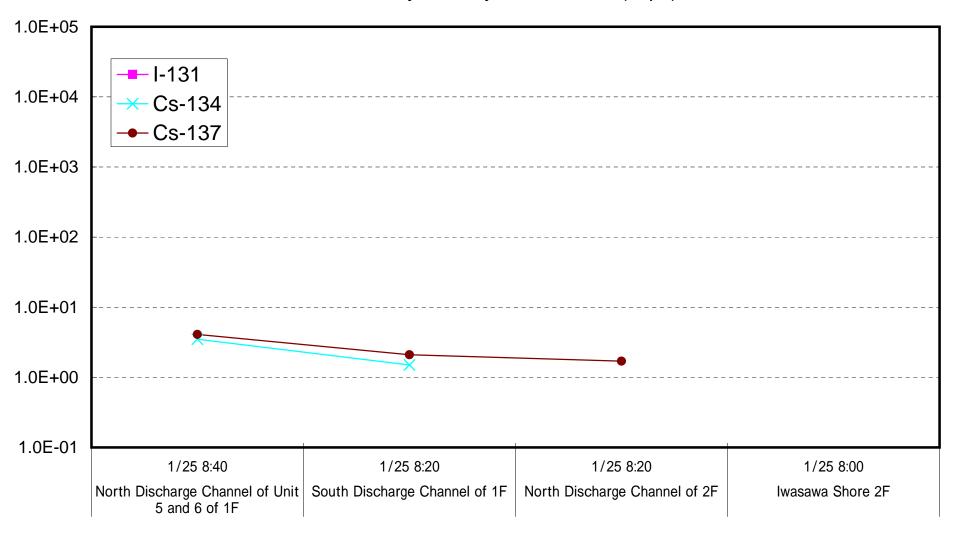

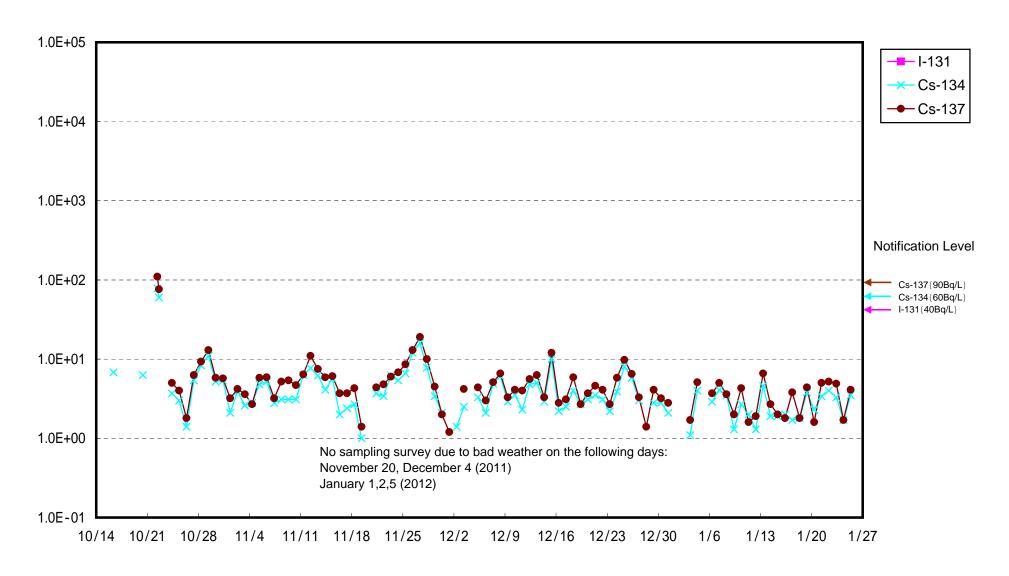

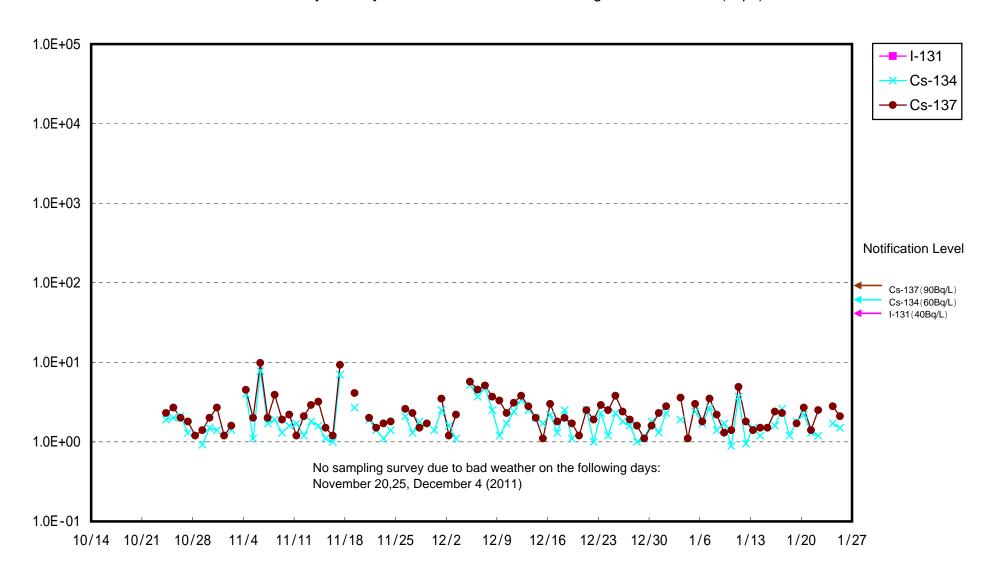
Radioactivity Density of Seawater (Bq/L)



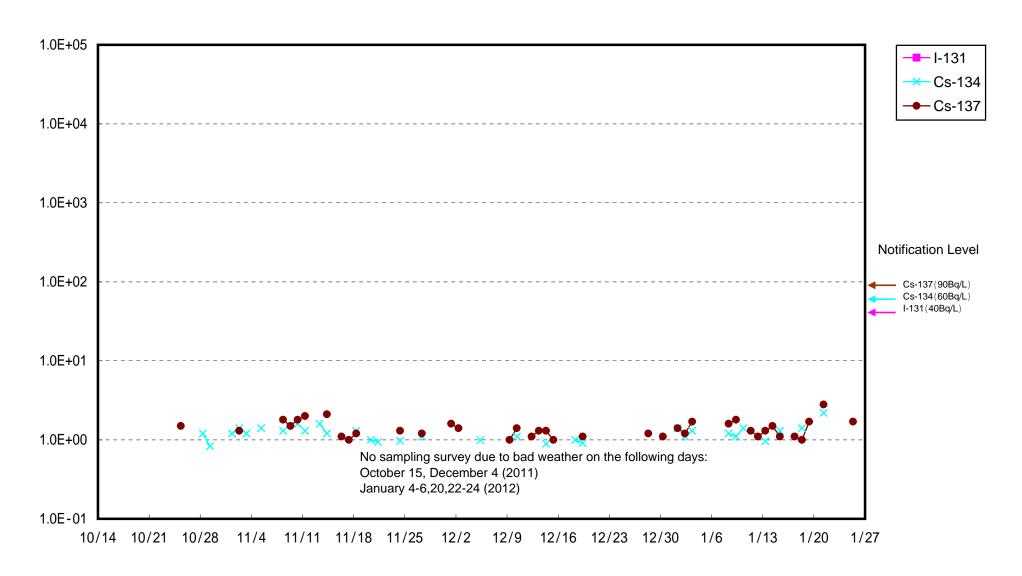
Radioactivity Density of Seawater at North of 1F5-6 Discharge Channel (Bq/L)
