

Fuel Cost Adjustment in Electricity Fees for September 2012

1. Fuel Cost Adjusted Unit Price

The following is the fuel cost adjusted unit price of the electricity rates in September.

With the electricity rate raise effective on September 1, the rate until August 31 will be calculated based on the former fuel cost adjusted unit price, and the new fuel cost adjusted unit price will be applied to the rate after September 1.

2. Impact on the average model of household electricity usage

Below is the average electricity rate per month (September) of household power usage. As mentioned above, the rate until August 31 will be calculated based on the former electricity unit price/ fuel cost adjusted unit price, and the new electricity unit price/ fuel cost adjusted unit price will be applied to the rate after September 1. As the rate is calculated per day, the actual payment amount will be the sum of the amounts "Old" and "New" divided by the number of days.

* "Old": Value calculated based on the electricity supply provisions, etc. effective on July 1, 2012 throughout the month.

* "New": Value calculated based on the electricity supply provisions, etc. effective on September 1, 2012 throughout the month.

* It is a case of 30A of meter-rate lighting B and 290kWh of electricity consumption per month. The figures include the Solar Surcharge, the Renewable Energy Promotion Surcharge, a reduction by automatic bank transfer discount and consumption tax, etc.

* The Solar Surcharge included in the payment amount is 17 yen and the Renewable Energy Promotion Surcharge included is 63 yen.
