*1 Consideration of the compensation equivalent to the expenses incurred due to evacuations or returning home, etc.:

As equivalent to the expenses incurred due to evacuations or returning home, etc., the compensation per person shall be set after the summation of the generally assumed amounts for primary claimed items, based on the information on the evacuation destinations and track records of compensation claimed, etc. The details are as follows:

For future settlement of compensation, if the total actual costs incurred exceed the compensation paid, the excess shall be additionally paid to the extent necessary and reasonable, regardless of the claimed items for summation. In addition, the handling of transportation expenses included in the amount equivalent to expenses incurred for evacuation or going home, etc. shall be in accordance with the conditions described in Section 1 (4) hereof.

(Applicable Compensation Period: From June 1, 2012 to February 28, 2014 where the former place of employment is located within the evacuation order area excluding the specific evacuation recommended points, or from June 1 to December 31, 2012 in any other cases). * As for any period that comes after the applicable compensation period, the handling of compensation for damage shall be determined after the specific circumstances applicable to an applicant are examined for review.

In addition, the handling of transportation expenses shall be in accordance with the conditions described in Section 1 (4) hereof.

Damages due to impaired work ability	Based on the earnings as of the date the Accident occurred, payment shall be made for a reduction in salary, etc. and increased commuting transportation expenses in accordance with “special effort” (as announced on June 21, 2012). (Applicable Compensation Period: From June 1, 2012 to February 28, 2014 where the former place of employment is located within the evacuation order area excluding the specific evacuation recommended points, or from June 1 to December 31, 2012 where the former place of employment is located within the former emergency evacuation preparation zone.
