* The numbers of dose and workers are subject to change, due to replacement of APD data to monthly dose data measured by integral dosimeter and reflection of workers who wear integral dosimeter (example: workers who entered only the Main Anti-earthquake Building).

*1: Depending on the prime contracting company, there are some cases in which the internal exposure dose is recorded at the WBC measurement month, rather than the intake month.

*2: Intrinsically, the internal exposure dose is intended to be recorded as an exposure dose for the month including the day the radioactive material was ingested (intake day). However, most records marked with a hast tag (#) have been recorded as an exposure dose for the month including the WBC measurement date and not the dose on the day of intake.

3 As there are areas in which the dose category delimiters and number of people per each segment are not consistent with previous reports, an asterisk () has been added to areas modified this time.
