On April 1, 2016, Tokyo Electric Power Company (TEPCO) will transition to a holding company system. Along with the transition, TEPCO's three businesses, fuel and thermal power generation business, general power transmission and distribution business, and electricity retail business will be taken over by three wholly owned subsidiaries, TEPCO Fuel & Power, Incorporated, TEPCO Power Grid, Incorporated and TEPCO Energy Partner, Incorporated, respectively.

In the Board of Directors meeting which was held on March 31, 2016, the following members were formally appointed as Executive Officers of TEPCO Holdings, Inc., effective from April 1, 2016. The Board of Directors also chose as follows the candidates for Directors and Auditors of each wholly owned subsidiary in the meeting. Those candidates' formal appointment as such will be announced after the meetings of the shareholders and the Board of Directors of each subsidiary.
